**NOTICE TO ALL PROPOSERS**

The Request for Proposal (RFP) is modified as set forth in this Addendum. The original RFP and any previously issued addenda remain in full force and effect, except as modified by this Addendum. Proposers shall consider this Addendum when preparing and submitting a proposal and shall acknowledge receipt of this Addendum in their proposal.

**PROPOSALS SUBMITTAL DEADLINE**

The proposal submittal deadline remains unchanged by this Addendum.  
**Proposals are due Wednesday December 3rd, 2025 by 3:00 PM (EDT).**

**ADDENDUM**

The RFP is modified as set forth below:

**REQUEST FOR CLARIFICATION/INFORMATION:**

1. In 2.2 General Requirements, Does MTA allow for ads other than the two full wrap options mentioned, such as kings, queens, and extended formats?

**Answer: Yes, MTA will allow for other advertising mediums on its vehicles so long as the advertising abides by the requirements in Section 2.2.**

2. In Section 2.3 Minimum Requirements for Pricing, the RFP states:  
“Proposer shall supply contract billing rate information detailing the billing rates for direct labor, overhead, and other direct costs for the proposer’s staff listed in the response and for all other staff included in the proposer’s organization that will be performing the services.” Since this is a revenue-generating contract, does this requirement apply? We have shared services across multiple transit authority contracts, so providing detailed billing rate information may not be applicable?

Answer: The third sentence of the third paragraph of section 2.3 does not apply to this RFP.

3. Can MTA provide a complete list of vehicle makes and models, along with clarification on which vehicles are used for fixed route service and which are used for demand response service?

Answer: Please refer to section 2.2 of the RFP document. Specifics on makes and models of vehicles and service routes will be shared with the awardee.

4. In Section 2.2.11 it states, "If MTA decides to use any of its interior or exterior advertising space, Vendor agrees to install MTA's advertisements at no charge within ten (10) days after receipt and to remove all advertising within three (3) days of the specified removal date." Will the vendor be responsible for the production of MTA's advertisements? If so, does MTA expect to pay the production costs? Or is MTA planning to supply these advertisements to the vendor for installation?

Answer: MTA will be responsible for producing its own advertisements that coincide with this RFP.

5. As MTA may be transitioning from one vendor to another, how will existing advertising revenue and current client contracts be handled? Specifically, how will those contracts be transitioned or honored as the new vendor assumes operations?

Answer: Currently there are no contracts past 12/31/2025, there are no accounts, revenue or clients to transition.

6. Does MTA have any limitations on window coverage for vehicle advertisements?

Answer: Please see section 2.2 regarding limitations on advertising/coverages. Any advertisements outside of the scope of work may be discussed upon award of the RFP.

7. To confirm, MTA is not including shelters in this RFP?

Answer: Please refer to section 2.2 #18 of the RFP.

8. To ensure a smooth transition and maximize program success, is MTA open to allowing a transition period before Minimum Annual Guarantee

**(MAG) payments begin, to provide the new vendor time to establish relationships with existing advertisers and begin active sales in the market?**

Answer: This item will be discussed with the awardee of this RFP.

**9. Please confirm if there are any contracts that run past the end date of the current contract and, if so, if those contracts will be transferred to the new vendor?**

Answer: Currently, there are no advertising contracts scheduled past 12/31/2025. Any transition of contracts extending past 12/31/2025 will be included in the contract approval process once the RFP is awarded.

**10. Please confirm who is responsible for the cost of required repairs due to issues outside the vendor's control (i.e. - accidents, retirements, etc.)?**

Answer: This item will be discussed during contract negotiations with the awardee.

**11. Can MTA please share the minimum annual guarantee for the last three years of the current contract?**

Answer: The minimum annual guarantee for the last three years has been \$120,000.

**12. Can MTA share photos and a location list of existing shelters so that we can see how'd we approach this for MTA?**

Answer: MTA typically has around 112 enclosures in use at any one time. An excel spreadsheet will be provided via email to all those on the current communication list for this RFP. The same excel spreadsheet will also be available via BIDNET.
