Comments of the Public

Ms. Kay Doerr, Mundy Township, spoke before board members regarding the proposed route for the Hill Road corridor, stating that she is in agreement with a route that accommodates all residents, giving better access to a broader area so that people are able to use facilities and businesses in that corridor.

Ms. Jennifer Stainton, Mundy Township, thanked Mr. Benning and MTA employees for working to make the Hill Road route accessible to everyone in the township. Ms. Stainton stated that several local businesses voiced the need for accessible transportation for work, students, and appointments.

Ms. Madyson Quick, Flint, stated that she participated in the MTA Fixed Route Study and is in support of the Hill/Torrey Roads route. Ms. Quick stated that plans for future route additions will be beneficial to the community.

Resolution #25-43 authorizing the General Manager to enter into an agreement with Midwest Bus Corporation, Owosso, MI, for the accident repair of Gillig Transit Bus #1235 at a firm fixed cost of \$142,053.00.
