Approval of the October 22, 2020 Annual/Regular Board Meeting Minutes

Ms. Lane moved, supported by Mr. Grossmeyer, to approve the October 22, 2020 annual/regular board meeting minutes. Roll call vote, eight (8) yeas; motion passed unanimously.

Approval of the October 19, 2020 Finance Committee Meeting Minutes

Ms. Lane moved, supported by Mr. Wilson, to approve the October 19, 2020 finance committee meeting minutes. Roll call vote, eight (8) yeas; motion passed unanimously.

Resolution #21-08 authorizing the General Manager to enter into a Real Estate Purchase Agreement on behalf of the Mass Transportation Authority for the sale of Building #3 (commonly referred to as the Weld & Restoration Lab) owned by the MTA at 1717 S. Dort Highway to The Disability Network, a 501(c)3 Corporation.

Ms. Lane moved, supported by Mr. King, to approve Resolution #21-08. Roll call vote, seven (7) yeas, one abstain; motion passed.

Resolution #21-09 approving the Mass Transportation Authority Pandemic, Epidemic and/or Local Health Emergency Response Policy / Procedure as required by the Michigan Occupational Safety and Health Administration Emergency Rules for Coronavirus Disease 2019 (COVID-19).

Mr. Grossmeyer moved, supported by Mr. Wilson, to approve Resolution #21-09. Roll call vote, eight (8) yeas; motion passed unanimously.

Resolution #21-10 authorizing the General Manager to enter into a renewal agreement with Employee Benefit Services Group for Group Dental Benefits, Group Life Insurance, and Short-Term Disability Benefits for January 1, 2021 through December 31, 2021, at a total cost of \$263,364.93 (using current MTA employee enrollment demographics).

Mr. Zelley moved, supported by Ms. Lane, to approve Resolution #21-10. Roll call vote, eight (8) yeas; motion passed unanimously.

Resolution #21-11 authorizing the Mass Transportation Authority Board of Directors to accept the MTA Public Transportation Safety Plan for Bus Transit as presented.

Ms. Lane moved, supported by Mr. Grossmeyer, to approve Resolution #21-11. Roll call vote, eight (8) yeas; motion passed unanimously.
